QRZ THE FREQUENCY THIS IS: (call sign), MY NAME IS: (1st name) I LIVE IN: (city & state),

I WILL BE NET CONTROL FOR THE CENTRAL GULF COAST HURRICANE NET THIS EVENING. THIS NET MEETS EVERYDAY ON 3935KHz LSB WITH EARLY CHECK-INS BEGINNING APPROXIMATELY 0730 CT OR AFTER THE WOLVERINE SSB NET & THE TEXAS NET CLEAR THE FREQUENCY. ANYONE WITH A GENERAL OR HIGHER AMATEUR RADIO LICENSE ARE WELCOME TO JOIN.

TO REMAIN ON THE “ACTIVE LIST” YOU MUST CHECK IN AN AVERAGE OF 3- OR MORE TIMES PER WEEK. THE “DAILY ACTIVE LIST” IS AVAILABLE FOR YOUR USE AT OUR WEB SITE; CGCHN.CAHABA.NET.

PLEASE, RESPECT PRECEDING NETS BY WAITING UNTIL OUR NET CONTROL IDENTIFY THEM SELF AND REQUESTS CHECK-INS.

THE PRIMARY PURPOSE OF THIS NET IS TO PROMOTE FELLOWSHIP BETWEEN AMATEUR OPERATORS, DOCUMENT COMMUNICATION CAPABILITIES AND SECONDARILY TO HANDLE ROUTINE TRAFFIC IN LIAISON WITH THE INTERSTATE SSB NET ON 3985 KHz.

THIS IS A DIRECTED NET, PLEASE DO NOT TRANSMIT WITHOUT BEING DIRECTED TO DO SO BY NET CONTROL. WHEN CHECKING IN PLEASE GIVE YOUR STATE, LOCATION, CALL, NAME AND TRAFFIC FOR THE NET.

ARE THERE ANY WHO MUST LEAVE THIS NET TO CONDUCT ANOTHER NET? (Acknowledge)

WE WILL NOW TAKE EARLY CHECK-INS

(at 8:30 PM)

WE WILL NOW CALL EACH STATE ON THE ROSTER FOR ADDITIONAL CHECK-INS, IF YOU HAVE PREVIOUSLY CHECKED IN YOU NEED NOT CHECK-IN AGAIN. AFTER ROLL CALL OF STATES, BAND CONDITIONS PERMITTING, WE WILL GO TO OPEN FORUM WHERE ANY SUBJECT PERTAINING TO HAM RADIO CAN BE DISCUSSED. NO POLITICAL OR RELIGIOUS SUBJECTS WILL BE USED—THESE SUBJECTS ARE PERSONAL AND SHOULD BE KEPT THAT WAY! (NCO can pick the topic for discussion or throw it open to public.)
